

CALF 2000

RELIANCE CALF 2000 is a high protein, mineralised and vitaminised calf pellet designed to support calf health and vitality.

RELIANCE CALF 2000 CONTAINS:

- Quality ingredients in a pellet for increased utilisation and reduced wastage.
- Highly digestible ingredients to stimulate rumen development.
- GutBoosta™ with prebiotics and essential oils for calf health and feed intake.
- The coccidiostat Bovatec® to help prevent coccidiosis.
- Molasses for increased palatability.
- Essential vitamins and minerals. This includes vitamins A, D and E, as well as B vitamins which are low in cow's milk.
- Trace elements such as cobalt, copper, selenium, iodine, manganese, iron and zinc.

Reliance feeds are part of Farmlands quality assurance program and are quality tested to meet their stated specifications.

Reliance calf feeds are made fresh.

FEEDING RECOMMENDATIONS

Feed RELIANCE CALF 2000 from four days after birth (after good colostrum intake has been achieved) or from week three to four after feeding RELIANCE CALF STARTMIX.

At three to four weeks transition to RELIANCE CALF 2000 then at eight to nine weeks transition to Reliance Calf 16%. At weaning, daily feed intake should be between 1 to 1.5kg/day depending on size and breed. Keep feeding RELIANCE CALF 16% for a minimum of four weeks post weaning. For optimum performance feed RELIANCE CALF 16% until six to eight weeks after weaning or a live weight of 100 to 120kg has been achieved.

Provide RELIANCE CALF 2000 along with fresh whole milk or calf milk replacer and grass or hay.

Ensure calves have access to clean drinking water at all times.

COCCIDIOSTAT

RELIANCE CALF 2000 with BOVATEC® 20CC

FOR ANIMAL TREATMENT ONLY

INDICATIONS: Contains 90mg/kg of lasalocid sodium as 450g/tonne Bovatec® 20CC A9679 as an aid in the control of coccidiosis caused by Eimeria species in cattle. To aid in the control of coccidiosis a minimum dose rate of 1mg lasalocid sodium/kg liveweight is required. Up to twice this dose rate is indicated where severe coccidial challenge is expected or a wide range of individual liveweights occur within a groups.

DIRECTIONS FOR USE: This product must not be used for growth promotion in ruminants intended for human consumption. By law the user must take due care, obtaining expert advice if necessary, to avoid unnecessary pain and distress when using the product other than as directed on the label.

CONTRAINDICATIONS: Care must be taken when feeding with other microbials. Do not feed with other ionophores e.g. monensin capsules, liquid or premix. Do not exceed recommended dose rates. Not to be used in a single dose treatment. This product must not be used for growth promotion in ruminants intended for human consumption.

CAUTION: Do not feed to Bobby calves. Do not allow consumption by dogs, alpacas (or other camelids), horses or other equids as ingestion by these species may be fatal.

WITH-HOLDING: It is an offence for users of this product to cause residues exceeding the relevant MRL in the NZ (Maximum Residue Limits of Agricultural Compounds)

MEAT: cattle and goats – nil.

MILK: Cattle - Nil.
