

# ECONO CALF

RELIANCE ECONO CALF is designed for situations where good volumes of milk are available up to 10 weeks of age.

## RELIANCE ECONO CALF CONTAINS:

- Quality ingredients in a pellet for increased utilisation and reduced wastage.
- Molasses for increased palatability.
- Essential vitamins and minerals. This includes vitamins A, D and E, as well as B vitamins which are low in cow's milk.
- Trace elements such as cobalt, copper, selenium, iodine, manganese, iron and zinc.
- The coccidiostat Bovatec® helps prevent coccidiosis.

ECONO CALF is available as a 6mm pellet for younger calves and as a larger nut for feeding on the ground for older calves, at pasture.

Reliance feeds are part of Farmlands quality assurance program and are quality tested to meet their stated specifications.

Reliance calf feeds are made fresh.

### FEEDING RECOMMENDATIONS

Transition from RELIANCE CALF 2000 to RELIANCE ECONO CALF at six weeks of age.

Provide RELIANCE ECONO CALF Plus Bovatec® along with fresh whole milk or calf milk replacer and grass or hay.

At weaning, daily feed intake should be between 1 to 1.5kg/day depending on size and breed.

Keep feeding RELIANCE ECONO CALF for a minimum of four weeks post weaning. For optimum performance feed until eight weeks after weaning, or a live weight of 100 to 120kg has been achieved.

Ensure calves have access to clean drinking water at all times.

### INGREDIENTS SELECTED FROM

Barley, Soyabean Meal, Canola, Soyhulls, Peas, Wheat, Maize, Oats, Soy Hulls, Palm Kernel Meal, Grass Seed Meal, Wheat By-products, Molasses, Vegetable oil, Minerals, Vitamins, Coccidiostat (Bovatec), Flavouring  
RELIANCE ECONO CALF contains up to 5% Palm Kernel Meal.

### BOVATEC 20CC®

**INDICATIONS:** Aids in the control of coccidiosis in cattle calves and goats. For coccidiosis control, minimum dose rate of 1mg lasalocid/kg liveweight is required per day (delivered in 1kg pellets for a 90kg calf). Up to twice this dose is indicated where severe coccidial challenge is expected or a wide range of individual live weights occurs within a group.

Ensure young animals are adapted to medicated feed for 2 to 3 weeks prior to weaning, as coccidial challenge is most likely in the 8 weeks after weaning. In any case, initiate treatment at least 2 days prior to expected coccidial challenge.

**CONTAINS:** Bovatec 20CC® at 450g/tonne of feed (90g/t lasalocid)

### MINIMUM FEEDING RATES FOR COCCIDIOSIS CONTROL:

CALF LIVEWEIGHT (KG)	FEED PER DAY (KG)
40	0.44
60	0.67
80	0.89
100	1.11

Milk additives containing lasalocid are available for use in situations where feed intake is inadequate to control coccidiosis.

### CONTRAINDICATIONS

Care must be taken when feeding with other microbials. Do not feed with other ionophores, e.g monensin capsules/liquid/pre-mix. Do not exceed recommended dose rates. Not to be used as a single dose treatment. Do not feed more than a total of 400mg lasalocid/head/day to lactating cattle. Do not feed to bobby calves.

### CAUTION

Do not feed to dogs, horses or other equids as ingestion by these species may be fatal.

### WITHHOLDING PERIODS

Meat: Cattle and goats - nil,  
Milk: Cattle - nil, goats - 35 days
